## **Producing knowledge about and for Africa in Germany and Brazil** **PROBRAL Collaboration Program**

### **Call for Applications – PhD Mobility Scholarship**

The International Collaboration Project “Producing knowledge about and for Africa in Germany and Brazil” is offering PhD students enrolled in any Graduate Program at UFBA, UFPE, and UNICAMP a tuition-free, full-funded opportunity to pursue part of their doctoral studies at the Institute for African Studies at the University of Leipzig, Germany.

Our project aims at connecting the spheres of knowledge production about and for Africa in Brazil and Germany through critical mutual reflection on historical and contemporary practices. On our agenda, we focus on the development of knowledge production on Africa with an increased role for knowledge from Africa. We seek to investigate theoretical, institutional, and political factors of scholarship on Africa and its circulation, taking Brazil and Germany as focal points. Our goal is to offer more and better opportunities for mobility to researchers of various academic levels and related to multiple disciplines of the Humanities to foster the internationalisation of participating institutions and, especially, the advancement of African studies in Brazil and Germany. The critical scrutiny provided by the project emphasises the interdisciplinary vocation and commitment to contemporary social issues and challenges, with special regard for research agendas promoted by African scholars and institutions.

We are selecting 2 PhD students to conduct research and engage in academic exchanges at the Institute for African Studies at the University of Leipzig, involving both established researchers and PhD students from Germany, Africa, and other parts of the world based in Leipzig, Bayreuth, and Berlin. Research proposals should focus on the dynamics of knowledge production about Africa and be related to the student’s ongoing PhD research.

The Institute for African Studies at the University of Leipzig is one of the leading centres in Germany for Africa-related research in the social sciences, including anthropology, politics, social and economic history, and reflections on the production of knowledge. The Albertina Library houses an extensive collection of books and other resources for African studies dating back to the 19th century. The university archive contains information on the history of the academic study of Africa and African students who studied at Leipzig. The institute projects itself as a centre for critical African studies. It has close collaborations with the university’s Institutes for Anthropology and Global Studies and with the Grassi Museum in Leipzig (one of Germany’s prominent ethnographic museums) and its extensive collection of African objects. The institute also collaborates closely with the two other leading German centres for African Studies, the University of Bayreuth and the Humboldt University of Berlin.

## REQUIREMENTS

To apply, you should:

- be a Brazilian citizen, a permanent resident in Brazil, or an applicant for permanent residency in Brazil currently on a student visa;
- be a regularly enrolled PhD student in any Graduate Program at UFBA, UFPE, or UNICAMP, doing research in the general field of African Studies, with an interest in investigating the history, politics, and pragmatics of knowledge production;
- have completed at least two semesters of your PhD course;
- have been approved in all PhD mandatory subjects and activities;
- have a deadline for completing your PhD that is later than October 2026;
- not have been previously awarded a PhD mobility scholarship from a Brazilian public funding agency.

## BENEFITS

Selected candidates will receive:

- an economy-class return trip to Germany;
- a €1,300 monthly stipend;
- a €1,300 lump sum to cover installation costs;
- a monthly €90 lump sum to cover international health insurance.

## ADDITIONAL INFORMATION

Research proposals should plan a minimum of 6 and a maximum of 10 months in Leipzig, starting in September 2025.

Mobility students will be assigned a local supervisor (see below a list of project participants in Germany). They should be based in Leipzig for the entire scholarship duration (except for short-term research trips). They are expected to attend project-related and other academic activities regularly and present the results of their research in a project seminar to be held in mid-December in Leipzig with members of the project team based in Germany and Brazil. Papers presented in the seminar are expected to be further developed and later submitted to an indexed journal (in Portuguese or English). Co-authoring arrangements, involving Brazilian and German team members, are enthusiastically welcome.

- an official ID;
- full academic transcripts of your PhD course;
- a curriculum vitae (printed from Lattes Platform);
- a research proposal, clearly identifying your research subject, outlining your conceptual framing and methodological options, together with a detailed work plan and timetable (max. 6p., in English);
- proof of language proficiency in English or German.

Foreigners should include a certificate they are permanent residents in Brazil, or their application for permanent residency together with a valid student visa.

Ensure all documents are in PDF format and your email message does not exceed 5 MB. Incomplete applications will not be considered.

Professor of History and Director of the Institute of African Studies, University of Leipzig. MA in History (1992) and PhD in Social Science (1998) on “In Search of Igbo Identity. Language, Culture and Politics in Nigeria, 1900-1966”, both at Leiden University. Taught at the University of Liverpool from 1999 until 2017. He works on the social, cultural, and economic history of West Africa, specifically Ghana and Nigeria, during the colonial period, decolonisation, and postcolonial period. This includes an interest in traditions of colonial, missionary and academic knowledge production about Africa, knowledge exchange from the perspective of African actors, as well as how African knowledge societies emerged and knowledge exchange took place. He has experience as Director of several MA programs, including Atlantic History, International Slavery, and African Studies. He was the founding Director of the Research Center for the Study of International Slavery in Liverpool and conducted collaborative projects with several museums, including the Liverpool World Museum, the Tate Gallery, the International Slavery Museum, and the Jenevermuseum.
